Enclosed, for your review and information is a copy of a Report to the City of Sebastopol, on the Laguna de Santa Rosa, prepared by the "Laguna Advisory Committee".

By way of background, the Laguna Advisory Committee is a 16-member citizen committee, which was appointed by the Sebastopol City Council in November, 1988. The Committee was asked to study the Laguna and to examine ways in which the Laguna could be protected. The Committee published its report in January, 1988. On January 19, 1988, the Sebastopol City Council received the Report, and referred it to the Sebastopol Planning Commission for review and recommendation.

The Sebastopol Planning Commission will hold a public hearing on the Report on Tuesday, March 22, 1988, at or after 7:00 p.m. at the Veteran's Memorial Building - 282 High Street, Sebastopol. The Commission would appreciate any and all comments on the Report. Written comments should be submitted prior to March 22 to the Planning Commission at 7425 Bodega Avenue, Sebastopol, Ca. 95472.
